2. It shall be ensured by the College/concerned State Government that:

i. Adequate funds are provided in (Plan) Budget regularly till all facilities are provided.

ii. 50% Seats are contributed to All India Quota (Except the Colleges in Andhra Pradesh, Telangana & Jammu & Kashmir)

3. This permission for starting/increase of seats in the above courses and admission of students will be till such time the first batch of students admitted against the above course (s) appears for the first final examination in the subject. The College authorities may take up the matter for recognition of the qualifications under Section 11(2) of IMC Act at the time of first batch admitted against the course appears for final year examinations.
