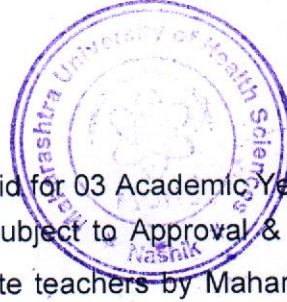

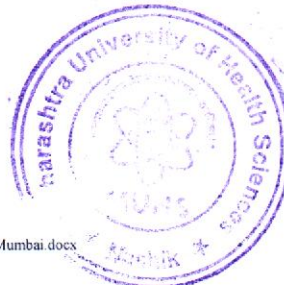
- This Consent of Affiliation shall be valid for processing of application for **three academic years** from date of issue.
