3. Bidders must quote prices for all items listed in the quotation; otherwise, the bidder will be disqualified from the bidding.

4. Both the envelopes should be addressed to - The Dean, Sir J J Group of Hospitals, Mumbai and marked **Kind attention to- Surgical store.**
5. **Vendors must write quotation reference no & Last date of submission of quotation on the envelope.**
6. Any amendments regarding the quotation will be published on website www.ggmccjh.in. Vendors will not be communicated separately regarding the amendments. However if the vendor fails to check any of these amendments on the website then it will be presumed that the vendor has quoted his/ her rates by taking the note of these amendments.
7. Rate should be quoted **inclusive of all taxes, GST, etc.**
